WELCOME & INTRODUCTIONS: A warm welcome was given to Kay Cope and Commissioner Chair Rollie Schmitten administered the oath of her office.

1. We will receive money back from paying B&O taxes that we had mistakenly paid. We will need to pay User taxes for online purchases, Kay will look into this matter.

- 2. Chief Lamar met with Kay, who requested that VEBA contribution be paid to her directly, versus participation in the VEBA plan. The Board agreed that Chief Lamar and Kay would work out the details to the employee's satisfaction.
- 3. LWFR will have a community meeting at Sta91 to receive public opinions on the purchase of the property. Chief Lamar has discussed with our attorney, Brian Snure, what are the best financial lines to follow.

We would also need 1. An Appraisal of the land, 2. A Community meeting and 3. A Bond Attorney.

The Commissioners are all in favor of moving forward with this project. The first week of November would be good for the Community meeting.
